- 1. Name/Number of Posts: Consultant-FoodTechnologist (01)
- 2. . **Scope of work:** To enhance the standards of existing products and help develop new value-added products.
- 3. **Period of Consultancy:** For one year. The consultancy period may be extended at the discretion of the Competent Authority subject to functional requirement, performance appraisal, fitness of the individual, etc.
- 4. **Job Location:** (1) Kerafed Oil Complex, Karunagappally, Kollam (2) Kerafed Coconut Complex, Naduvannur, Kozhikode
- 5. **Eligibility Criteria & Experience: a)** Post-graduation from a Govt recognized University in Food Safety/Food technology/Food and Nutrition/Oil technology. (In the absence of the above, a Diploma in Food Technology from a Govt recognized University will be considered).
