Interested bidders must submit their sealed quotations, superscribing "Tender for supply of 1000 MT of Copra" (No: 002/24-25) to the KERAFED Head Office, Thiruvananthapuram on or before 09.08.2024 at 02.00pm. (Tender will be open on 12.08.2024 at 3 pm)

Bidders can offer a minimum quantity of 200 MT of copra and can increase their bid in

#### Eligibility Criteria for Bidders

Income Tax & PAN: Bidder must provide a copy of their Income Tax returns for the last Two years along, with a copy of their PAN card, both attested by authorized signatory,

GST Registration: Bidder should have a valid GST registration,

Processing Facility: Bidder's must own or lease a copra Processing facility anywhere in the country. Documentation proving this must be included with the bid.

#### > Scope of Supply

- Loading and Transportation: The successful bidder is responsible for all costs associated with loading and transporting the copra.
- Unloading: The cost of unloading the copra will be covered by KERAFED.

**PTO** 

- Delivery Period Delivery of Copra should be completed within 30 days only for 1000 MT, whereas for 200 MT it should be 20 days on receipt of confirmed purchase order from KERAFED. The supplier shall have to ensure that the supply of each phase is made strictly in accordance with the time schedule given below:-
  - 50 % of copra as per purchase order should be supplied within the 15 days of issue of P.O.
  - The balance quantity of 50% of copra should be supplied within the remaining days as mentioned in the purchase order.
  - Quantity can be supplied +/- 10% of the PO quantity is allowed.
- Payment Terms Payment will be released within 20 days on receipt of stock at our factories.
- Rate Rates should be quoted as rate per Quintal + GST.
- EMD ₹ 5 Lakh by way of DD drawn in favour of Managing Director, KERAFED payable at Thiruvananthapuram. On receipt of confirmed P.O from KERAFED, if the party fails to supply stock, EMD will be forfeited.

## Quality Parameters

- Moisture content not above 6%, mouldy wrinkled and fungus affected cups upto 14% will be accepted without any price cut but moisture content upto 7% will be accepted with quantity cut proportionate to moisture content. Moisture content above 7% will be rejected.
- ✓ Inferior copra with rubbery, mould & fungus affected cups shall not above 14%. However, inferior copra above 14% to 18% will be accepted by inposing cut on the value @0.25% for every 1% inferior copra above 14% but Inferior copra above 18% will be rejected.
- ✓ Oil content in copra not below 68%.
- The weight of the bag containing copra will be adjusted by Kerafed to determine the actual weight of the copra. Kerafed has established a standard deduction norm of 1.09 kg per bag for single bag instances. Should a bag exceed this specified weight, the actual weight of the bag shall be deducted. Kerafed retains the authority to carry out this procedure in its entirety
