KERAFED (Kerala Kera Karshaka Sahakarana Federation Ltd.) is inviting qualified and experienced housekeeping service providers to submit their Expression of Interest (EOI) for the provision of comprehensive housekeeping services at the **KERAFED Coconut Complex**, located at **Naduvannur, Kozhikode** and KERAFED Oil Complex located at Kaunagappally, Kollam

**Scope of Work**

The contractor shall deploy a team of skilled personnel to provide housekeeping services at the **KERAFED Coconut Complex Naduvannur and Kerafed Oil Complex Karunagappally**, ensuring high standards of cleanliness and hygiene across all areas of the premises. The services will cover the entire complex, including offices, meeting rooms, production areas, administrative offices, Godowns, Washrooms and Factory premises.

**Key Responsibilities Include:**

- **General Cleaning and Upkeep:** Ensuring cleanliness in all areas of the facility, including offices, Factory Buildings, Machinery corridors, staircases, elevators, lobbies, bathrooms, and surrounding outdoor areas.
- **Timely Completion:** Ensuring that all office areas are cleaned and presentable by **9:30 AM** each working day, with cleaning commencing by **8:00 AM**. And factory buildings and production areas, before or after the production time.
- **Area-Specific Cleaning:** Regular cleaning of the Oil Mill area, substation rooms, dryers, go-downs, Packing and Filling Section, Boiler , storage areas and administrative buildings, Toilet blocks, security rooms, canteen, weigh bridge section, value added plant, and premises of the entire factory building.
- **Sanitary Maintenance:** Replenishing toiletries, waste management, and upkeep of furniture and office equipment.
- **Waste Disposal:** Segregate and Disposal of different category of waste at designated areas as per local self-government rules.
- **Gardening:** Regular maintenance of the factory premises, including gardening services.

## Detailed Scope of Services

### 1. Daily Tasks:

- **General Cleaning:** Sweeping, vacuuming, mopping, and wiping of office and factory floors, staircases, lifts, meeting areas, and cabins.
- **Furniture & Equipment Cleaning:** Dusting and polishing of furniture, office equipment, Shelves, Tables, windows, blinds, and electronic devices.
- **Sanitary Maintenance:** Scrubbing and cleaning of toilets, wash basins, sanitary fittings, and mirrors.
- **Replenishment of Toiletries:** Replenishing hand towels, liquid soap, toilet rolls, air fresheners, and tissue boxes.
- **Waste Disposal:** Daily removal and disposal of waste (food, non-food, and plastic) in accordance with local self-government rules.
- **Area-Specific Cleaning:** Regular cleaning of the Oil Mill area, substation rooms, dryers, go-downs, Packing and Filling Section, Boiler, storage areas and administrative buildings, Toilet blocks, security rooms, canteen, weigh bridge section, value added plant,

### 2. Weekly Tasks:

- **Deep Cleaning:** Vacuuming and shampooing of carpets, cleaning of light fixtures, fans, air-conditioning vents, and other equipment.
- **Machine & Equipment Cleaning:** Deep cleaning of machines and equipment in the Production areas.
- **Gardening Services:** General maintenance and upkeep of indoor and outdoor plants, including watering and trimming.

### 3. Monthly Tasks:

## **Tools, Equipment, and Supplies**

The contractor is responsible for providing all cleaning equipment, including but not limited to:

- Vacuum cleaners, brooms, mops, dusters, cloths, and cleaning solutions.
- Gardening tools and supplies (for indoor/outdoor plants).
- Consumables required for daily, weekly, and monthly tasks Including toiletries, bathroom fresheners).

## **Service Delivery and Timelines**

- **Daily Services:** All cleaning tasks must begin at **8:00 AM** and be completed by **9:30 AM** to ensure the facility is ready for business by 9:30 AM.
- **Weekly/Monthly Tasks:** These tasks will be carried out during **non-production time** to ensure the regular operations of the facility are not disrupted.

## **Supervision and Reporting**

- A **Housekeeping Supervisor** will be designated by the contractor to oversee the housekeeping services and liaise with **KERAFED** management for any additional requirements.
- The supervisor will provide regular progress reports on the completion of daily, weekly, and monthly tasks.

## **Additional Requirements**
