- **Security Deposit:** 10% of the total tender value to be remitted prior to lifting the stock. This amount will be adjusted against the final consignment.
- **Payment Terms:** Full advance payment via Demand Draft or RTGS is required before lifting the stock.
- **Rate Quotation:** Rates should be quoted per Metric Ton (MT). GST and other applicable taxes will be extra.

- **Delivery Period:** Entire stock must be lifted within 45 days from the date of issue of the Sale Order.
- **Loading & Weighment:**
 - Loading charges will be borne by KERAFED.
 - Transportation, unloading, and applicable taxes are to be borne by the buyer.
 - Weighment will be conducted at the KERAFED factory weighbridge and the weighment recorded at this plant shall be considered final and binding for all billing and delivery purposes.
 - Weight includes gunny bags; individual bag weights may vary.
